TELL US: WHY MIND THE GAP?

NETWORK and NETWORK Education Program (NEP) invite you to participate in the *Mind the Gap!* contest for young justice seekers. Create a short video (5 minutes or less) demonstrating why wealth disparity in the United States is an issue for all of us, and you could win a trip to DC to showcase your video at NETWORK's 40th Anniversary Celebration.

While the submission is a video, your project could be anything – want to write a song, or cover your street with sidewalk chalk? – just make sure to get some footage and explain how you shared why **you** mind the gap. Finalists' videos will be shared with thousands of NETWORK members and e-activists, and one winner will be invited to present her or his video at the NETWORK 40th Anniversary Celebration in Washington, DC

TERMS & CONDITIONS:

ELIGIBILITY

The *Mind the Gap! Contest* (the "Contest") is open to all persons age 18 -25 (must be a minimum of 18, and no older than 25, by April 4, 2011). Employees of NETWORK, NEP or their families or any parties involved in the design, promotion or management of the Contest are not eligible.

HOW TO ENTER

Starting at 8:00 a.m. Eastern Standard Time ("EST") on January 1, 2012 (Initiation Date) participants can enter the Contest by submitting their entry form to Shannon Hughes at mindthegap@networklobby.org. All entries must include full name, complete address (including city, state or province of residence, and postal code), and daytime phone number with area code, age and e-mail address. There is a limit of one entry per person. In the event that any entrant attempts to enter more than once, all of that entrant's entries will be disqualified from this Contest. Any use of automated entry devices is prohibited.

To enter, upload a video (no longer than five (5) minutes) to YouTube and email your completed submission form to mindthegap@networklobby.org and/or mail your completed submission form and a DVD with your video on it to NETWORK Education Program, Mind the Gap! Video Contest, 25 E St. NW Suite 200, Washington, DC 20001.

Videos longer than five minutes will automatically be eliminated. **Use your video to demonstrate why the wealth gap is an issue for the people of the United States. The video can be the medium through which you communicate with your audience, or can document you engaging this topic directly in your community. The video should demonstrate why you believe we need to mind the wealth gap. Because NETWORK and NEP work in the spirit of Catholic Social Teaching, including this perspective is encouraged, but not required.** All videos will become the property of NETWORK and NEP.

CONTEST CLOSING DATE

To be eligible to win the Grand Prize Package, all entries must be received at the above email address, or mailed to the above address, no later than 11:59 pm EST on Thursday March 1, 2012 (Closing Date).

GRAND PRIZE

There will be one (1) Grand Prize Package winner. The Grand Prize Package for each winner consists of:

- One (1) roundtrip airline ticket from a city within the United States to the Washington, DC area
- Ground transportation to and from the DC area airport to accommodations in Washington, DC
- Two (2) nights (April 13th and 14th, 2012) lodging accommodations in Washington, DC
- Being honored at NETWORK's 40th Anniversary Celebration

The Grand Prize Package, as described, is subject to availability, may not be exchanged for cash, is non-transferable, non-refundable, non-saleable, and must be accepted as awarded, without substitutions.

NETWORK and NEP are not responsible for trip cancellation or disruption brought about by weather, flight cancellations, or any other factor beyond its control including, but not limited to denial of airline boarding. NETWORK and NEP are not responsible for increased or additional costs incurred by the contest winners as a result of any extraordinary factors.

GRAND PRIZE PACKAGE REQUIREMENTS:

The Winner must follow all instructions of NETWORK and NEP and their designated representative(s) including the Contest designers. If all related instructions are not adhered to, participation in the Grand Prize Package may be forfeited, in whole or in part.

As part of the Grand Prize Package, the Winner will be participating in the 40th Anniversary events throughout the day on Saturday, April 14th. As part of Contest entries, all entrants thereby declare their ability and willingness to do so.

ASSOCIATED COSTS

As a requirement of the Grand Prize, the selected entrant (the "Winner") shall be responsible for the following:

- all ground transportation to and from the Winner's local airport
- all gratuities, meals, transportation, trips, incidentals, applicable taxes, and any and all other associated expenses not specified in the above

DOCUMENTATION

The Winner is responsible for ensuring that all travel papers (forms of identification, etc.) are in good order, and are valid prior to, and for the entire duration of, the Grand Prize Period.

All required documentation for the Grand Prize Package will be sent via courier directly to the Winner's home only after the Winner has met the eligibility requirements outlined in these Contest Rules and Regulations.

These forms must be signed by the Winner and returned to, and received by, NETWORK Education Program, Mind the Gap! Video Contest, 25 E St. NW Suite 200, Washington, DC 20001, no later than March 23, 2012.

GRAND PRIZE AWARD JUDGMENT

NETWORK and NEP will select one (1) Winner by Monday, March 12, 2012 (Selection Date) from all eligible entries received on or before the Contest Closing Date.

The first attempt to contact the selected Winner by telephone will be within three (3) business days of the selection date. If the Winner cannot be contacted within Five (5) business days of the first contact attempt, he or she will be disqualified, and an alternate entrant will be selected. Furthermore, failure to complete and return the official contest documentation by March 23, 2012 will result in the Grand Prize Package being forfeited and another entrant will be selected.

All decisions of the judges are final in all matters relating to this Contest.

GENERAL CONDITIONS

NETWORK and NEP reserve the right, at their sole discretion, to cancel or suspend this Contest at any time, for any reason, without any prior notice.

All Contest entries and associated videos become the property of NETWORK and NEP.

All Contest entries are subject to verification and will be declared invalid if they are forged, falsified, altered or tampered with in any way.

By entering the Contest, entrants consent to the use of their name, city of residence and image on videotape and/or photograph in any future form(s) of publicity of NETWORK and NEP with respect to this Contest and the Mind the Gap! Campaign, without further notice or compensation.

By participating in this Contest, entrants acknowledge compliance with, and agree to be bound by, all Contest Rules and Regulations, including eligibility requirements.

Entrants release and hold harmless NETWORK and NEP, from and against any and all manner of action, causes of action, suits, debts, covenants, contracts, claims and demands, including legal fees and expenses, whatsoever, including but not limited to, claims based on negligence, breach of contract and fundamental breach and liability for physical injury, death, or property damage which the entrants or his/her administrators, heirs, successors or assigns might have or could have, by reason of or arising out of the entrant's participation in the Contest and/or in connection with the acceptance and/or exercise by the entrant of the Grand Prize awarded.

This Contest is subject to all applicable Federal, State, Provincial and Local Municipal laws.
